Updates from the HIT Council: August 1, 2016

Regulations Update

EOHHS is currently developing regulations regarding requirements to have a fully interoperable EHR and connections to the Mass HIway.

During the June 6th meeting, the Council raised six topics in regards to the regulations currently in development:

- 1. Defining Provider Organizations
- 2. Requirements for Provider Organizations with multiple entities
- 3. How the Direct Messaging requirement relates to Quality/Public Health Reporting
- 4. Defining sending and receiving HIway Direct Messages to meet the requirement
- 5. Incorporating Provider to Provider (P2P) communications outside of the HIway
- 6. Further clarification of Centralized opt-out for HIway-Sponsored Services

EOHHS discussed these topics with Advisory Groups and other stakeholders for further development of the regulations.

The proposed regulations timeline aims to promulgate regulations by January 2017 with anticipated public hearing and public comment period during Fall 2016.

Special notice:

EOHHS anticipates that requirements will be phased in over a number of years, with the initial focus on hospitals, larger medical ambulatory practices, and community health centers. EOHHS anticipates that certain Provider Organizations, including behavioral health practices, dental clinics, and small and solo practitioners, will have a required connectivity date that is later than January 2017 and will be given a 1 year notice.

Increasing Provider-to-Provider Coordination on the HIway

Goal: Improve patient transitions of care among provider organizations through increased use of HIway Direct Messaging.

Approach: Support provider organizations with workflow modernization using Mass HIway resources who are experienced with technology and workflow improvement.

- 1. Establish technical readiness with provider organization and trading partner(s)
- 2. Engage clinical and business leadership (this is not an IT project)
- 3. Undertake one very focused care transition workflow improvement
- 4. Iterate with additional provider organizations and uses
- 5. Share lessons learned

Examples of clinical workflows targeted:

- Patient transition at discharge (e.g., Hospital to primary care)
- Patient transition at admission (e.g., Skilled nursing to Emergency Department)
- Patient transition(s) at referral (e.g., Primary care to Specialist consult and back)
- Administrative simplification (e.g., Mail/Fax/Scan/Attach process to Direct messaging process)

Work is underway with 6 provider organizations!

Interested in getting involved? Mass HIway is looking to expand this work to other provider organizations and trading partners with the following attributes:

- *Aligned high priority clinical goals* (e.g., Reduction of re-admissions, elimination of medication errors at care transitions)
- *Aligned incentives* (e.g., Meets meaningful use objectives for Health Information Exchange and Medication Reconciliation, Satisfies accountable care contract)
- Intra-organizational workflow required among two motivated organizations (e.g., Coordinated primary and hospital care)

This map will be updated by Mass HIway and MeHI monthly, and is accessible at either:



Usage and Availability Trends

Mass HIway maintained 100% availability for July and 99.73% availability in June. Of the last 13 months, availability dipped below the target 99.9% only 5 times. Successful stabilization efforts have contributed to:
