### MeHI Grant Awardees Announced

The Massachusetts eHealth Institute (MeHI) at MassTech has awarded \$193,000 to four electronic health record vendors to build efficient pathways for 12 Massachusetts behavioral health providers to electronically submit reportable data to the state's Children's Behavioral Health Initiative (CBHI).


