HIway Attestation Deadline was July 1, 2018

As described in Section 5.2 of the <u>Mass Hlway Policies and Procedures</u>, all Acute Care Hospitals, Large Community Health Centers, and Large and Medium Medical Ambulatory Practices in the Commonwealth of Massachusetts were required to submit an Attestation Form **by July 1, 2018** explaining how they had met the requirement to connect to the Mass Hlway in accordance with 101 CMR 20.00 (also known as the <u>Mass Hlway Regulations</u>).

Important Information:

- The July 1, 2018 deadline has passed for Acute Care Hospitals to attest to the Year 2 connection requirement, and for Large Community Health Centers and Large and Medium Medical Ambulatory Practices to attest to the Year 1 connection requirement. Even though the deadline has passed, the Hlway urges all Provider Organizations with a connection requirement to make a submission. Online Attestation Forms, which include guidance for completion and submission, can be accessed here, in the section regarding "Mass Hlway Attestation Form."
- The online Attestation Form must be completed in one session. Data cannot be entered and saved for completion at a later time. If you are not ready to complete the full online Attestation Form at this time, we suggest that you use the PDF version of the Attestation Form to plan and prepare responses, then complete the online version when all of your responses are ready. PDF versions of the Attestation Forms are available by clicking the appropriate link: Year 1 Attestation Form, Year 2 Attestation Form.
- If an organization has not fulfilled its Hlway connection requirement and cannot complete the Attestation Form, an authorized representative of the organization must still submit information to the Mass Hlway. See section 3.8 of the <u>Mass Hlway</u> Regulations FAQs for detailed instructions.

Hlway 2.0 and Clinical Gateway Node Migration

This is for informational purposes only for Participants that submit data to the various Public Health and other nodes via the Clinical Gateway. The Clinical Gateway Nodes will be upgraded to the latest standards. No action is needed from Participants, and the migration is seamless. Here is the latest schedule:

Migrated to Hlway 2.0 during May, June, and July:

- MCR Massachusetts Cancer Registry
- CLPPP Childhood Lead Poison Prevention Program
- **PMP** Prescription Monitoring Program
- **eREF** eReferral Program

Scheduled for Migration in July and August:

- MIIS Massachusetts Immunization Information System
- **SYND** Syndromic Surveillance Program
- OTP Opioid Treatment Program
- CBHI Children's Behavioral Health Initiative
- ELR Electronic Lab Reporting



Mass Hlway Transaction Data


11,068,050 Transactions* exchanged in June 2018 (05/21/2018 to 06/20/2018**)

Sev 1 - All / Most Mass Hlway components impacted as a result of outage. For example: LAND, Webmail, Direct XDR, and DPH nodes are all down

Sev 2 - Multiple Mass Hlway components impacted as a result of outage in one of the shared service. For example: LAND and Webmail are down but Direct XDR and DPH nodes are up.

^{1 **} Note: Reporting cycle is through the 20th of each month.

Sev3 – One Mass Hlway component impacted as a result of outage. For example: Webmail is down but all other services are up and running.
